**The Orthodontic Care Program is our core program. This unique program is a reactive process that provides orthodontic care for children growing up in impoverished households who are suffering from severe orthodontic problems and have been turned down by Medicaid or other government funded programs.**

**Working with community partners, we first identify a child, meet with the family to verify the financial need, provide two orthodontic exams to validate the medical need, and bring our findings to our Board of Trustees for a final decision. With Board approval, we finance the costs directly with an orthodontist until treatment is successfully completed. The process concludes through an exit interview with the family. In the**

It was established in 2000 and named in Dr. Rubin's honor to commerate his sincere dedication to providing good dental care to children. His goal was to help students develop favorable attitudes toward personal oral health habits through awareness, education and demonstration.**
